OLD BUSINESS:

Members were provided an opportunity to review the May 23, 2023 meeting minutes.

Motion: A motion to accept the minutes was made by Major Hildreth and seconded by Major Post. The minutes of the May 23, 2023, meeting were approved.

NEW BUSINESS

Budget Update

Director Hartman introduced Michelle Sparks-Raymond from FDLE to the council. Sparks-Raymond gave the council a brief presentation covering the trust fund and its rules.

Director Hartman provided an overview of new changes at FPSI's business office and the introduction of Tawana Carter as the Region's fiscal agent. Ms. Carter and Amy Bradbury, Director of Financial Services, briefly addressed the council about the final quarter of FY '22-'23. Major Hildreth requested that a copy of the current budget be emailed to the council, including the current budget balance.

Chairman Himmer began a discussion about reciprocal funding. It has been long-standing that FPSI does not charge out-of-region officers' tuition as long as the said region extends the same courtesy to Region 15. The council was asked if they wished this to remain the standard or if payment of all out-of-region officers should be sought. After discussion, it was agreed that it was more important for officers to receive training than to receive the reciprocal funding. The Council will not seek reciprocal payments from other regions, to include Region III.

Commission Updates

Executive Director Hartman presented the updates from the CJSTC commission meeting on August 7-10, 2023.

- All prior rules proposed by FDLE regarding changes to various instructor requirements and updated curricula for high-liability topics were approved by the commission (Appendix A). FPSI began following these rules as of July 1, 2023. Correct forms that relate to the new rules were not uploaded correctly by FDLE. As of last week, all forms have been updated and are current.
- Renaming the CJSTC firearms instructor course was discussed since the course dropped rifle and shotgun instruction. No decision was made at this time.
- Following attendance at the Florida Police Chief Conference, the Florida Training Center Directors Association established an adhoc committee to discuss officer mental health and suicide awareness. Region XV members and FPSI volunteered to sit on this council.

Academy Updates

Director Hartman addressed the facility hardships that have recently plagued FPSI.

- Three chillers have gone down in various buildings leading to temporary air condition units being
 installed. All facilities currently have appropriate air conditioning, and replacement units/parts have
 been ordered.
- FPSI has been in communication with instructors who teach outside classes such as firearms and
 vehicle operations. They have been advised to be cognizant of the heat and contact FPSI if they need
 assistance combatting it.
- Greg Eastman, Facilities Maintenance, is retiring on 8/11/2023. AimsFacility Tracking has been implemented as a way for staff to submit help tickets for facility and maintenance issues.
- FPSI and TCC's welding program have partnered to build and repair the metal firearms target racks.
- 25Live will be undergoing updates to include a reminder feature.
- The helicopter pad will be refurbished and serve as the future home for Survival Flight Air-Medical.
- Director Hartman wishes to create an advisory council for the new dormitory and how it can best meet agency needs. She requested that each agency provide a representative to serve on this committee.
- FWC has partnered with FPSI to refurbish and build fixed and floating docks for better diving and boating training.
- Moving forward, Chairman Himmer will request updates from all training academies.

Course Updates

- Chief Johnson received an inquiry to look into the possibility of the region supporting the cost of a CJSTC Marshall-specific course. After discussion, more information was needed before a decision was made. Chief Johnson will report back to the council at the next meeting with additional information about the course.
- The council was presented with currently scheduled classes for Region 15. No other discussion was had. It was mentioned that FPSI is working to continue to schedule courses around the state.
- The council was presented with an instructor pay template (Appendix B) that would guide pay caps for region-funded courses. FPSI acknowledged that only Council members determine how instructors are compensated and the overall costs of the individual courses. Monetary amounts were assigned to categories of courses, and FPSI will not pay instructors more than allowed by that category. Costs exceeding the category cap will be presented to the council for discussion and approval.

Motion: A motion to accept the pay template was made by Major Hildreth and seconded by Deputy Director Lowers. The instructor pay template was adopted.
